In response to the rise in the number of healthcare fraud and abuse cases and the escalating cost of healthcare services, the U.S. Centers for Medicare and Medicaid Services (CMS) has instituted compulsory training and compliance programs for individuals and organizations who provide health or administrative services to Medicare or Medicaid enrollees or who receive payments from the Medicare/Medicaid system. These training and compliance programs help establish fundamental expectations for compliance, disclosure, transparency, and quality of care.

Medicare/Medicaid Fraud Waste and Abuse compliance for an organization revolves around establishing a formal compliance program to detect, correct, report, and prevent fraud waste and abuse in an organization and a compliance training program to establish fundamental expectations for compliance, disclosure, transparency, and quality of care when working with the Medicare/Medicaid system and its enrollees.

As part of satisfying the Fraud Waste and Abuse compliance requirements established by the Centers for Medicare and Medicaid Services (CMS), employers are required to provide a Fraud Waste and Abuse awareness training as well as a CMS General Compliance training to all employees within 90-day of hiring and annually thereafter.

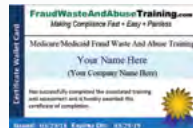
